

# Foreigners on the labour market in Opolskie Voivodship in 2021


U **122,4** Dynamics of the number of work permits issued to foreigners in relation to 2020 In Opolskie Voivodship, in 2021, 13.9 thousand work permits were issued to foreigners, i.e. by 22.4% more than in the previous year. Work permits were most frequently issued to citizens of Ukraine. There were 0.1 thousand foreigners registered in powiat labour offices of the voivodship, i.e. by 22.5% fewer than at the end of 2020

## Work permits for foreigners<sup>1</sup>

In 2021, voivode of Opolskie Voivodship issued 13.9 thousand work permits to foreigners, which constituted 2.8%, similarly as a year before and in 2015 – 1.9% of all permits issued in the country. The number of permits issued was higher by 22.4% than in the previous year, and in comparison with 2015 it increased more than 11 times. The vast majority of work permits issued concerned men (77.7%).

# Chart 1. Work permits for foreigners




When analysing the structure of permits issued by the applicant's age, it can be observed, that in Opolskie Voivodship in 2021, the greatest number of foreigners who were granted a work permit was among people in the age group of 25–34 years (31.3%) and 35–44 years (28.7%), and the lowest among people over 64 years of age (0.2%) as well as in the age group of 60-64 years (1.5%). In case of male foreigners, the biggest share was in the age group of 25–34 (34.7%), while among women in the age group of 45–54 (28.6%).

In 2021, in Opolskie Voivodship, work permits were issued to citizens of 48 countries in total. They were most often awarded to citizens of Ukraine. In the analysed year, 75.4% foreigners who obtained work permits had a passport from that country. The percentage of work permits issued to citizens of other countries was significantly lower. In 2021, work permits were issued most often, excluding citizens of Ukraine, to residents of India – 3.9% of the total number of permits issued, Uzbekistan – 2.4% and Belarus – 2.2%.


#### Chart 2. Structure of work permits for foreigners by citizenship in 2021



From the analysis of the structure of work permits by their period of validity, it can be deducted that in 2021, in Opolskie Voivodship the most common ones were issued for the period over 6 months up to 12 months (55.0% of the total number of permits). Permits with validity period over 24 months accounted for 25.0%, whereas work permits valid over 12 months up to 24 months made up 19.9% of their total number. Short-term work permits valid for up to 6 months accounted for 0.1% of their total number.


The majority of work permits for foreigners concerned employment under order agreements (58.6%). In this category, 63.6% of contracts were concluded for a period exceeding 6 months up to 12 months. The second most popular form of employment was a labour contract (40.6%). Among labour contracts, the largest number (43.2%) concerned contracts for a period of more than 6 months up to 12 months.






In 2021, the most work permits were issued to employers in the manufacturing section (2.6 thousand) which accounted for 30.3% of the total number of permits. A considerable percentage were permits issued to employers in the construction section (28.7% of the total number of permits) as well as transportation and storage (16.6%). Permits issued in these three sections jointly accounted for 75.6% of all issued work permits.





Work permits were most often granted in manufacturing

Taking into account the number of work permits issued according to major occupational groups of the Classification of Occupations and Specialisations, it can be concluded that in 2021, in Opolskie Voivodship the most numerous group were craft and related trades workers (34.0% of the total number of permits issued). A considerable share was also observed for elementary occupations (28.6%) followed by plant and machine operators and assemblers (19.7%).





## **Registered unemployed foreigners**<sup>2</sup>

At the end of December 2021, in powiat labour offices of Opolskie Voivodship, there were 0.1 thousand registered unemployed foreigners. Their number, in the total number of the registered unemployed accounted for 0.4%, similarly to the year before, and in 2015 – 0.2%. In comparison with 2020, the number of registered unemployed foreigners decreased by 22.5% and in relation to 2015, by 4.8%. Over a half (62.0%) of registered unemployed foreigners were women.
